Type: Time Extension–Excavation & Stockpiling (Stripping and Grading)

Any person who deems to be affected by the issuance of this permit may appeal to the Subdivision and Development Appeal Board by 4:30 p.m., September 15, 2022. On Permitted Uses, grounds for appeal must relate to questions of interpretation, variance, or relaxation, and not to the proposed use. On Discretionary Uses, all aspects of the proposed development may be challenged upon appeal.
