## TAKE NOTE

### TRANSIT HUB AND COCHRANE INNOVATION CENTRE BORROWING - BYLAW 06/2020

Cochrane Town Council proposes to pass a borrowing bylaw to finance construction of the Transit Hub and Cochrane Innovation Centre in the amount of \$4.4 million. The borrowing is expected to be repaid over a 30-year timeframe and will not impact property taxes, as the debt will be repaid from rental revenue.

The public may inspect the proposed bylaw at Legislative Services, Cochrane RancheHouse, Mon-Fri, 8:30am-4:30pm. Electors may submit a separate petition with respect to the advertised bylaw calling for a vote of the electors to determine whether the proposed bylaw should be passed. The petition must meet the formal requirements of Sections 221-226 of the Municipal Government Act and be filed with the Manager, Legislative Services by February 7, 2020, 15 days from the last date the proposed bylaw is advertised. Any petition is public information. This bylaw will be considered by Cochrane Town Council at the Monday February 10, 2020 Council Meeting.

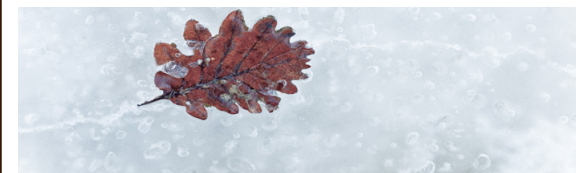

# Animal Licensing Renewal Date Moves To January For 2021

Animal licensing renewals will move to a simple, annual payment every January.

To move away from the staggered-monthly payment system, pet owners will receive their licence renewals in their usual month, however the amount will be prorated to the end of the calendar year.

In December 2020, pet owners can expect to receive a renewal notice for 2021, to be paid by January 31, 2021.
